## USE DATA TO OPTIMIZE PROCESSES

By collecting the right data on product returns, you can understand why customers may be returning products. Then, you can make adjustments in sales, product design and forward logistics processes accordingly.

## **A TRACK PRODUCTS FORWARD AND BACKWARDS**

Linking raw materials to the finished good and the customer order allows you to trace ingredients in the event that you need to process recalls—instead of issuing them for entire lines, you can find the issue and selectively issue recalls. This also enables you to understand where logistics jams might be happening and how to fix them efficiently.



## **CENTRALIZE RETURN CENTERS**

Centralizing return centres to more effectively create economies of scale and reduce backlog. Better sort products and identify the best next step for each of them. Efficiently determine how best to reclaim product value. If your company lacks the resources to have a separate returns center, consider dedicating a portion of your warehouse or factory to returns.
